- School staff do run clubs. E.g. Marvellous maths club, Drama Club, Mindfulness, Homework and Calm Club. However, they also have a number of meetings to attend after school and lesson marking and preparation to complete, so their time after school is limited.

Staff are consistently looking into ways to improve communication with parents so that no parent is unduly worried about their child's progress. There are many ways in which the school keeps parents informed and it may be helpful to list them:

- Three parent consultations are held for all parents across the school year, one in each term.
- Annual reports are sent home in the summer term.
- In this school year, we introduced the Interim Report so that parents have information during the year in addition to the annual report sent home at the end of the summer term.
- Parents of children with additional needs are involved in the setting and reviewing of targets on My Plans.
- This year we have tried to increase our parent workshops so that parents can be fully informed on their child's learning and how to support them. In addition to the phonics session we have run Accelerated Reader and Maths in KS1 workshops. We will continue to run them at different times so that all parents have an improved opportunity to attend.
- The school values home and school partnerships. We encourage parents to be proactive in meeting with the teachers we are here to support your child's educational journey. If you need advice or want to talk, do not wait for a questionnaire, make an appointment.

Four parents felt that children do not receive appropriate homework for their age. This was from a mixture of parents with children in different year groups across the school. We do not know whether these parents were concerned with too much and/or too little homework being given.

The school's policy for the provision of home learning to pupils and has been drawn up in accordance with guidance issued by the DfE, recognising that 'home learning tasks should be carefully designed to meet the child's individual needs, including children with special educational needs.'

The school will review the content and quantity of homework before the next academic year.

We are heartened that most parents feel that the school deals effectively with bullying but it is clear that many of our parents feel that they do not know. Our approach to the prevention and resolving of bullying is as follows:

- On those very rare occasions when children's conflicts are serious the school implements its 'Anti Bullying Policy' which enables adults to facilitate the children in expressing their own views, taking responsibility for their action and developing their own solutions. This policy is available to all parents on our school website.
- Our PSHE curriculum covers anti-bullying and most importantly the religious and spiritual element of the school greatly contributes to developing an ethos of love, care and respect within our community.
- Our E-Safety curriculum covers cyber bullying.
- Every class addresses the annual Anti-Bullying Week by the AntiBullying Alliance.
- Each classroom has a 'Action Against Bullying A Guide for Children' and this is referred to frequently.

The Local Governing Board of St Joseph's School is compelled to adopt and comply with all policies, protocols and procedures of the Multi-Academy Trust Company, the Bishop and the Diocesan Bishop as communicated to the Local Governing Board from time to time.

Why do we have Governors?

The governing body is accountable for the performance of the school and it fulfils this by setting the aims of the school and its priorities for improvement. It agrees monitors and evaluates the policies, targets and actions by which the school will move forward, including setting and monitoring the school budget.

The governing body's role is strategic. Governors are not expected to be involved in the detail of the day-to-day management of the school. The head teacher has responsibility for the internal organisation, management and control of the school and for implementation of the strategic framework established by the governing body. The governing body works in partnership with the head teacher and the senior leadership team. The governing body has a role to support and challenge the work of the school.

Governors must act corporately. Individual governors do not have the power to act alone unless the corporate governing body has given them the authority to do so. Individual governors have a broadly representative role but they are part of a team. They are not delegates and do not have any kind of mandate from the body who elected or appointed them.

What do governors do?

The full governing body meets regularly. In line with its strategic role, its focus for these meetings is school improvement. The governing body receives a report from the head teacher and discusses issues arising from this report. Most governing bodies manage a substantial part of their work through committees. We currently have two committees – Resources and Teaching & Learning. We welcome any interest in the work of the governing body.
